Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

In connection with this, the Housing Authority was awarded Tenant Protection Vouchers to enable the relocation of the residents there. The project began occupancy in December of 2021 and was completed in the Spring of 2022.</p> <p>The Housing Authority of the City of Frederick awarded eight (8) project-based vouchers at a renovation/new construction tax credit project at 520 N. Market Street. Furthermore, 76 vouchers were project-based after the renovated Catocin View Apartments. Project-basing is consistent with the PHA Plan in that it helps to expand affordable housing opportunities. Vouchers may be project-based at other projects as well.</p>

	<p>The Housing Authority of the City of Frederick has been awarded 9% Low-Income Housing Tax Credit funding for a new construction project named South Street Centre. South Street Centre will consist of two buildings offering both family and senior apartments. Construction began in Spring of 2022.</p> <p>The Housing Authority of the City of Frederick is also considering the possibility of participating in RAD for Lucas Village and also for the mixed-finance projects of Hillcrest Commons and Frederick Revitalization I.</p> <p>The Housing Authority of the City of Frederick will be applying for demolition and/or disposition of the Lucas Village project. In connection with the disposition, the Housing Authority has requested Tenant Protection Vouchers so that the residents of the units can be relocated, which is necessary for the demolition phase to take place. The HA intends to redevelop the land for additional affordable housing opportunities.</p> <p>The Housing Authority will apply for other capital grant programs when they are available to meet its capital needs.</p>
